Sub: Sanctioning of Weekly off to all categories of employees – Reg.

Respected Sir

You are aware that the NVS teaching staff, including the Principal and the Vice-Prinicipal, have no defined working hours. The study supervision, mess and late night dormitory duties engage them for over 16 hours a day. Almost all teachers are put to duty on Sundays and other gazetted holidays. This is depriving them of private life and they have not been able to give quality time to their family members. This, in turn, affects the quality of their professional work. In fact, they do not get enough time for the preparation of their next day's duties. This kind of routine will fail to draw the best out of the staff in the long run.

It is needless to say that all the employees deserve to have a weekly off. It is no luxury to allow the staff to attend their familial work on Sundays and other holidays. Engaging them on holidays without any compensatory leaves is totally unconstitutional. The staff deprived of their holidays will be forced to attend to their domestic work on week days. This, sometimes, causes rupture between the administration and the staff, besides causing stress to the staff.

The NVS has recently made it clear that weekly off is mandatory for all employees working in JNV. However, sanctioning a weekly off to the staff has been left to the discretion of the principals. While a few principals sanction a compensatory leave for working on holidays, most principals continue to deny the staff of their much deserved weekly off on the grounds that they have no instructions from the headquarters in this regard. The absence of uniformity is causing distress to the staff.

The Association has planned a tentative arrangement of duty teachers on Sundays and other holidays, which has been enclosed herewith. It requests the NVS to go through it and consider it for uniform implementation across the country. The staff who are put on duty on holidays should be sanctioned a compensatory leave within a week of their performing their holiday duties. This reduces the conflicts between the staff and the principal and helps the smooth functioning of the vidyalaya.

It believes that the Hon'ble Commissioner has left no stone unturned to convince the Ministry of the necessity of not abolishing the allowance as it was sanctioned under special conditions and as a special case.

AINVSA sincerely appeals for the restoration of 10% special allowance as per VII CPC revised pay scales to the teaching staff and to extend the same allowance to the non-teaching staff.

NVS is requested to adopt the same rules like its sister organization, KVS, and ensure that the creative teachers are not denied of the meagre financial benefits by suitably amending the rules.

The management has promised to adopt the same rules that its sister organization has adopted but the promises have not materialized.
