Sir/Madam,

Kindly refer to this office letter of even number dated 03.09.2013, wherein instructions were issued regarding the selection of candidates for the Departmental Exam to the post of Principal. Vide para 2 and 3 of the above referred letter, it was conveyed that:-

- (1) The Departmental Exam for the post of Principal is only for the vacancy arising up to December, 2013.
- (2) Qualifying cut-off marks would be decided 40% for the General category and 35% for SC/ST category candidates for Written Exam as well as Personal Talk.

In supersession to above, it has been decided that this Departmental Exam for the post of Principal would be valid for two recruitment years, i.e., for 2013 and 2014.
