Sub: Pension Case hearing on 26-04-13, and collecting funds and relevant document – Giving top priority – Reg.

This is to bring to your urgent attention that the Writ Petition filed by the Association through the General Secretary, Shri L. B. Reddy in the hon'ble Supreme Court is listed for hearing on 26-04-13. Earlier on 05-4-13 the Hon'ble Apex Court's website displayed the hearing date as 12-04-13 but the latest change in date was displayed on 06-04-13. Our case No. 556/2012 has been considered as a lead case now and the other two cases filed by Shri P.N.Mishra, and Shri Khannan and others are also likely to come up for hearing on the same day. The NVS is expected to submit its affidavit in response to our petition but it has not done so far. We expect that the affidavit may be filed on any date before 26-04-13.

The Association has already appealed to vidyalaya units to collect a sum of Rs.200 from each member. Though some of the vidyalayas have already responded, many vidyalayas have not responded yet.
